

## BUS SERVICE Contract

Convenient for you and fun for your student, our bus service makes two morning and afternoon stops. Our stops are The Centre at Riverchase (departing promptly at 7:05 a.m.) and The Colonnade (departing at 7:25 a.m.). The afternoon bus departs from the school at dismissal. Children are dropped off in the afternoons at the same stops and in the same order (Riverchase, then The Colonnade due to traffic patterns).

Our drivers are CDL holders — trained, certified commercial bus drivers responsible for conducting an orderly, safe and enjoyable journey to and from campus. Families may elect to use round-trip or one -way service.

I/we understand that we will be billed for this service regardless of absences or unforeseen school closings. Cancellation of this contract is allowed only if the family moves out of the designated pickup areas. I/we understand that Highlands School will need a minimum of ten participants enrolled by August 1, 2017 in order to provide bus service during the 2017-2018 school year and that without that minimum, service may not be provided.
